The Board has declared a dividend of €0.025 per Euro Share in respect of the period from 1 July 2016 to 30 September 2016. The above dividend represents an increase from the dividend of €0.02 per share paid on 19 August 2016, and follows the announcement of the increase in target dividend from 8% p.a. to 10% p.a. made on 2 September 2016.
