The Board has declared a dividend of €0.025 per ordinary share in respect of the period from 1 October 2019 to 31 December 2019.

This dividend is payable on 28 February 2020 to shareholders on the Company's share register as at the close of business on 31 January 2020, and the corresponding ex-dividend date will be 30 January 2020.

The dividend is capable of being paid in Pound Sterling, rather than Euros, provided that the relevant shareholder has registered to receive their dividend in Pound Sterling under the Company's Dividend Currency Election, or registers to do so by the close of business on 7 February 2020.
