#### **Blackstone / GSO Loan Financing Limited ("BGLF" or the "Company")**

The Board has declared a dividend of €0.015 per ordinary share in respect of the period from 1 July 2020 to 30 September 2020.

This dividend is payable on 27 November 2020 to shareholders on the Company's share register as at the close of business on 30 October 2020, and the corresponding ex-dividend date will be 29 October 2020.

The dividend is capable of being paid in Pound Sterling, rather than Euros, provided that the relevant shareholder has registered to receive their dividend in Pound Sterling under the Company's Dividend Currency Election, or registers to do so by the close of business on 6 November 2020.

The Dividend Currency Election Form should only be completed by shareholders who hold shares in certificated form.
